Daarnaast worden wij technisch ondersteund door Creative Work uit Buitenpost en vind de hosting plaats via Realhosting. Inmiddels dicht getimmerd met contractjes zodat ze zorgvuldig met je gegevens om gaan.

Als je bij ons hebt besteld kom je op de maillijst. We proberen het mailen te beperken want ik heb er zelf ook een hekel aan. Doorgaans gaat er om de 2 weken een mailtje uit. Hier staan dan nieuwe producten of aanbiedingen in vermeld. Wil je ze niet meer ontvangen dan kun je heel eenvoudig afmelden onder aan de mailing: afmelden voor deze mailing. Super eenvoudig en met 1 klik geregeld. Mochten we naast waterpijpen een andere leuke aanbieding voor je zien waarvan wij je op de hoogte willen stellen, dan ontvang je uiteraard ook een mailtje. ## **Security**

## **How we use cookies**

A cookie is a small file which asks permission to be placed on your computer's hard drive. Once you agree, the file is added and the cookie helps analyse web traffic or lets you know when you visit a particular site. Cookies allow web applications to respond to you as an individual. The web application can tailor its operations to your needs, likes and dislikes by gathering and remembering information about your preferences.

We use traffic log cookies to identify which pages are being used. This helps us analyse data about web page traffic and improve our website in order to tailor it to customer needs. We only use this information for statistical analysis purposes and then the data is removed from the system.

Overall, cookies help us provide you with a better website, by enabling us to monitor which pages you find useful and which you do not. A cookie in no way gives us access to your computer or any

information about you, other than the data you choose to share with us. You can choose to accept or decline cookies.
